## AIMS

Our main aim for maximum impact of the Pupil Premium Grant (PPG) is to narrow the gap between pupil groups. As a school we have an excellent track record of ensuring that pupils make good progress from Key Stage 1 to Key Stage 2.

The number of pupils we have eligible for Pupil Premium Grant is extremely low; 0% predicted in 2017-18, compared to 25.2% nationally (2015-16). Through targeted interventions we continue to eliminate barriers to learning and progress, and narrow the attainment gap through careful monitoring and individually tailored plans for accelerated progression.
